Park Updates:

Shale Hollow parking: Parking blocks are in and we are awaiting dry conditions to finish grading and seeding the berms.

SHP business plan: In order to cover the cost of providing internet connectivity, Wi-Fi and maintenance activities for the lodge at Shale Hollow staff are developing a business plan set rental rates and promote reservations.

DHP Pollinator Garden: The ground has been prepared for planting, the gravel and flag stone walk ways are in and planting will begin today. Additional planting will occur this fall and spring of 2016.

Survey: 240 completed surveys have been received. 1500 surveys will be mailed to households that have not responded and we expect to exceed the goal of 300 completed surveys.

Meredith Closing: On Monday we closed on 1.6 miles of rail road right-of-way – from Meredith State Road to North County Line Road.

Public records request: The firm SmartProcure requested copies of all purchase orders from 1-1-2010 to the present. The county Auditor's office was able to supply the information.

New Business:

1. Meredith State Trail contract award. Bids were received on June 19th. Bids ranged from a low

bid of \$366,390.10 to a high bid of \$395,909.15 as compared to the Opinion of Probable

Construction Cost of \$375,000.00. The low bidder is Facemyer Landscaping, LLC of Sunbury,

Ohio whose bid has been reviewed and found to be in conformance with all requirements. It is

our opinion that they are experienced and qualified to perform the work within the contract. D.

Boysel moved to award the contract to Facemyer Landscaping, J. Bader seconded and all

members voted aye.
